Fees

You decide what level of support your employees receive through this program. At the highest level of support, Platinum, the organization fee is the number of employees in your group times the \$90 full government rate. Or, if you decide upon a sharing approach to membership, at the Gold level, the organization fee is the number of employees in your group times \$45. At this level, the employees share the cost of membership by paying the remaining \$45 each for the full government rate of \$90. At the Silver level, the organization fee is the number of employees in your group times \$30. And the employees share the cost of membership by paying the remaining \$60 each for the full government rate of \$90.

Applying These Benefits

Taking advantage of the Organization Member Program can result in significant savings for your staff's professional training and development. This is because **ADVANTAGE** members receive reduced member rates on national training events and products.

For example, a government agency enrolls as a Platinum Supporter and pays \$450 for a group membership for five employees. Over the next year, the agency sends its group members and five non-group members to AGA's annual Professional Development Conference & Exposition (PDC).

Since one of the exclusive benefits of **ADVANTAGE** is paying the member rate for a number of the agency's employees attending an AGA nationally sponsored conference like the PDC, the **ADVANTAGE** member agency would save \$200 per non-member (the difference between the member and non-member conference rates) or a total of \$1,000 for the five non-members it is allowed to send at the member rate. Thus, the \$1,000 savings more than covers the \$450 that the agency paid for the group membership.

In another example, an agency enrolls as a Silver Supporter and pays \$300 for its group membership that includes 10 employees. Then, each of the 10 employees remits the balance of the membership fee, which is \$60 each or \$600. Over the next year, the agency sends several group members and 10 nonmembers to the PDC. The agency would save \$200 per nonmember for a total of \$2,000. The \$2,000 savings more than covers the \$300 that the agency paid for the group membership.

The **ADVANTAGE** organization member program is an excellent way to invest in the professional development of your staff!
