The Certified Public Accountant (CPA) designation is the most common certification, followed by the Certified Government Financial Manager (CGFM) designation. These numbers are expected to increase as the Chapter follows its mission of fostering professional development and certification.



# Revenues and Expenditures



## Challenges Moving Forward Membership Retention / Education

The Chapter is pleased to report that we are able to provide low-cost, CPE qualifying, luncheon meetings.
