#### Aloha Everyone,

Thank you for your outstanding support during the past year. I am privileged to lead the chapter for the next year and hope to continue the momentum started by the past president, Dallas Weyand II. Thanks to his leadership, our chapter is considered a leader in implementing AGA initiatives.

At the annual AGA national professional development training conference in Orlando, Florida, I received several comments regarding the accomplishments of our chapter. For example, AGA national staff publicly complimented us during open sessions on the progress and precedents we have set for CCR reporting. The AGA National President lauded us on the unique Citizen Centric Report (CCR) that our chapter members, Shena Bocalbos and Ryoko Lung, submitted for AGA's National Case Challenge. The video streaming and focus on performance persuaded the judges to award Hawaii the grand prize for CCR reporting.

At the conference, our chapter participated in a panel that discussed the impact of CCRs and how it was used by government leaders. The audience was surprised to learn that our CCRs could be used to evaluate an entity's performance, prioritize issues, and to make decisions relevant to public concerns. Members of the audience expressed a desire to learn and partner with us.

Although we are in the middle of the Pacific, several AGA national leaders and Pacific Rim delegates expressed interest in visiting and partnering with us on continuing education programs. AGA's National President expressed his gratitude for the leadership our membership has provided to the Pacific Basin and the national AGA programs. Recognition of our chapter's accomplishments also exists at the local, municipal level. In August 2014, the Honolulu City Council awarded Shena Bocalbos and Ryoko Lung, a special certificate in recognition of their national prize for winning the AGA National Case Challenge.

From September 10 to 11, 2014, the AGA Hawaii Chapter is hosting a seminar at the Hale Koa hotel in Waikiki. The continuing professional education workshop will focus on the new and evolving governmental auditing standards (also called the Yellow Book) and will provide 16 CPEs and meals at a cost of \$300 for members. During the seminar, our new AGA national president, William Miller, has arranged to be present and looks forward to meeting members of our chapter.

The chapter momentum continues on September 13 when all AGA Hawaii Chapter members are invited to participate in a community service project on board the USS Missouri. ## <u>Audit Plan Development: Linking Risk to</u> Resources



His office also streamlined audit reports, set many other pioneering efforts for the auditing profession, and has won numerous awards for their audit reports and pioneering efforts.

## Pacific Rim Region History By: Clarence Kuwahara

Approved by the national organization in late 1999, the region started off with a bang by a visit to all Pacific Rim chapters (Japan, Guam, Northern Marianas Islands and Hawaii) by national president W. A. Broadus, national executive director Charles Culkin and Pacific Rim Regional Vice President Clarence Kuwahara in July 2000. As described in an article in AGA's national newsletter, *Topics*, the visits covered 11 time zones, six nights and days with Thursday and Friday experienced twice in Saipan and Hawaii. Excellent visionary ideas were offered, many of which and much more already have been accomplished since the commencement of the region. Most importantly, the quality of AGA programs and services has improved throughout the region, and accordingly, AGA's reputation as well.

#### The region's accomplishments include:

- Regular visits to all chapters by national presidents and other high level AGA officials (Prior to 2000, only the Hawaii chapter was visited on a regular basis).
- The Honolulu based Pacific Emerging Issues Conference (PEIC) rose to even higher levels.
- Coordinated educational programs to maximize speaker and financial resources.
   Examples: (1) Service and Efforts Accomplishments Reporting (SEA) presentations in Guam, Marshall Islands and Hawaii and (2) Presentations by Bill Broadus in Guam and Hawaii.
- The Guam chapter commenced its own version of the PEIC in August 2006, which
  impressed high level national leaders and others who were in attendance from the
  mainland United States.
- Greatly increased interest in CGFM certification and classes in the American Pacific governments.

#### <u>Important Milestones:</u>

Prior to establishment of the region:

- December 1998 Japan, through Mike Martin (Air Force) expressed interest in reestablishing chapter.
- September 1999 Pacific Rim Roundtable held in conjunction with PEIC in Honolulu, which
  was attended by key national/regional/chapter leaders and officials, and key providers.
  The Roundtable produced visionary ideas for the region, including the idea of establishing
  the Pacific Rim as a separate AGA region. The meeting was facilitated by national
  president- elect Bill Broadus.
- November 1999 Japan Chapter re-inaugurated with Mike Martin (Air Force) as president.
- December 1999 National executive director Charles Culkin informs Pacific Rim region that it has been approved as a separate AGA region.
- February 2000 Clarence Kuwahara (Hawaii) and John Phillips (Guam) were formally elected as the first Pacific Rim regional vice president and regional vice president-elect, respectively.

## Pacific Rim Region History (continued)

#### After establishment of the region:

- July 2000 Visits by national president Bill Broadus, national executive director Charles Culkin and regional vice president Clarence Kuwahara to all chapters in region.
- August 2001 PEIC in Honolulu rose to new levels, attracting a record 202 paid attendance and 250 overall, including a delegation from China.
- April 2002 First ever Pacific Rim regional chapter officers workshop held in Guam in conjunction with a meeting of the Association of Pacific Island Public Auditors.
- August 2003 ASMC joined AGA and the Western Intergovernmental Audit Forum as a PEIC conference sponsor and increased paid registrations by 35%.
- July 2004 Jay Fountain (GASB) presented seminars on Service and Efforts
   Accomplishments Reporting to the Guam Chapter, the Association of Pacific Island Public
   Auditors meeting in the Marshall Islands, and the Hawaii Chapter. By working together, the
   costs were minimized for all concerned.
- June 2005 National President Bobby Derrick and Senior Vice President Clarence Kuwahara made a successful visit to Japan to revitalize the Japan Chapter.
- August 2006 Guam Chapter holds first biennial PEIC. Speakers included national
  president Jeff Hart, Senior Vice President for Regional Services Lee Miller and past national
  president Bill Broadus. A highly successful regional chapter officer's workshop was held,
  attended by members of all chapters and seven of the current and past regional vice
  presidents.
- August 2008 Guam Chapter holds second biennial PEIC.

#### **Technical presentations**

W.A. Broadus, Jr., CPA, CGFM

Mr. W. A. (Bill) Broadus, Jr., heads his own Professional Corporation. W. A. Broadus, Jr., CPA, PC, and is currently practicing as a consultant in the governmental and nonprofit area. Prior to that, he was employed with the U.S. General Accounting Office. During his employment, he served in a number of wide and diverse assignments with increasing responsibilities in both the Cincinnati Regional Office and the

Washington D.C. Headquarters' Office. From 1975, until leaving GAO in February 1990, he worked with federal, state, and local governmental officials in the financial management areas. He also served as an adjunct accounting faculty member at the American University for 12 years. His academic experience includes serving on the following accounting advisory boards: University of Nevada at Las Vegas; Louisiana State University; James Madison University; University of Michigan; University of Oklahoma and the American University.

Bill will cover several topics. The first will be an update on federal single audit requirements coming from OMB. Second will be and update of federal cost principles and administrative rules affecting recipients of federal grants. The afternoon session will address the new Green Book (internal controls) and how it incorporates the new COSO model. Bill will also cover GASB revisions.

Government Financing Challenges: The luncheon speaker is Kalbert Young, Director, State of Hawaii Department of Budget and Finance. Kalbert has extensive financial management experience and was the Director of Finance for the County of Maui before becoming Director of Finance for the State of Hawaii.
