The Certified Public Accountant (CPA) designation is the most common certification, followed by the Certified Government Financial Manager (CGFM) designation. These numbers are expected to increase as the Chapter follows its mission of fostering professional development and certification.

The AGA Hawaii Chapter has been offering its members a number of affordable opportunities to further their knowledge and keep current on the latest technologies, governmental auditing and financial reporting issues while earning Continuing Professional Education (CPE) credits to maintain and enhance their professional careers. 

## **Revenues by Source**


